Thursday 7th Dec – TrustMark Forum being held at BEIS after EHC Board meeting, dependent upon the outcome of the Board meeting the TrustMark Scheme Operators will be advised of the changes that are being sought to the current TrustMark Scheme along with the requirements for the schemes to engage and support the transition from the old to the new. The new structure of the business will also be advised and the schemes are currently members and have a liability under the articles.

Key roles for urgent recruitment will be the Governance Manager to support the work stream looking at the changes to the Boards, we will also be seeking to appoint a Compliance and Audit Director to support the development of the Framework Operating Requirements from the end of January.

Early February - Enact the new Articles of association for Governance and delivery of the quality mark Board.

1st June **2018** appoint Independent Directors to the quality mark Board, following appointment of new Directors disband existing RSC and reform from independent Directors to complete the appointment process for the Industry and Consumer Directors.

30th June 2018 – Industry and Consumer Council's pass nominations for Directors role on quality mark Board to RSC for consideration. RSC forwards preferred candidates to the Board for decision and appointment to the Board. To be completed by the end of August 2018.
